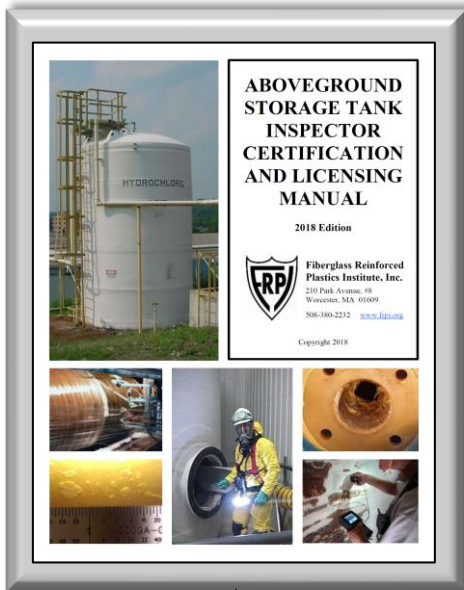




Aboveground Storage Tank Inspector Certification Tracks

Body of Knowledge



- Manual is prerequisite for each program track.

Tank inspector credentialing options are summarized herein. Simply purchase the Manual, participate in a one (1) or four (4) day course and then complete any remaining program steps. Track 1 offers minimum education to build experience required for inspector certification thru Track 2, where Track 2 is for any level inspector, leads to FRPI 8310 Inspector credentialing and may qualify inspector to pursue FRPI SP9100 tank plus odor and air pollution control vessel installation inspection required for SP9000 certified manufacturers. Track 3 is for inspectors desiring credentials required for pursuing SP9100 installation inspection only. An Inspector in Training (IIT) is welcome to start learning and credentialing through participation in Track 1, 2 or 3.

- Closed and open book
- Pass = SP8310/Install cert
- Exam fee applies
